- Complete Course Progress Reports (as assigned by Advisor) by scheduling a meeting with instructors.
- Maintain the required cumulative GPA for your desired college (intended major/college may be changed by student during his/her time in CAT) and a 2.0 Quarter GPA during final quarter in CAT:
