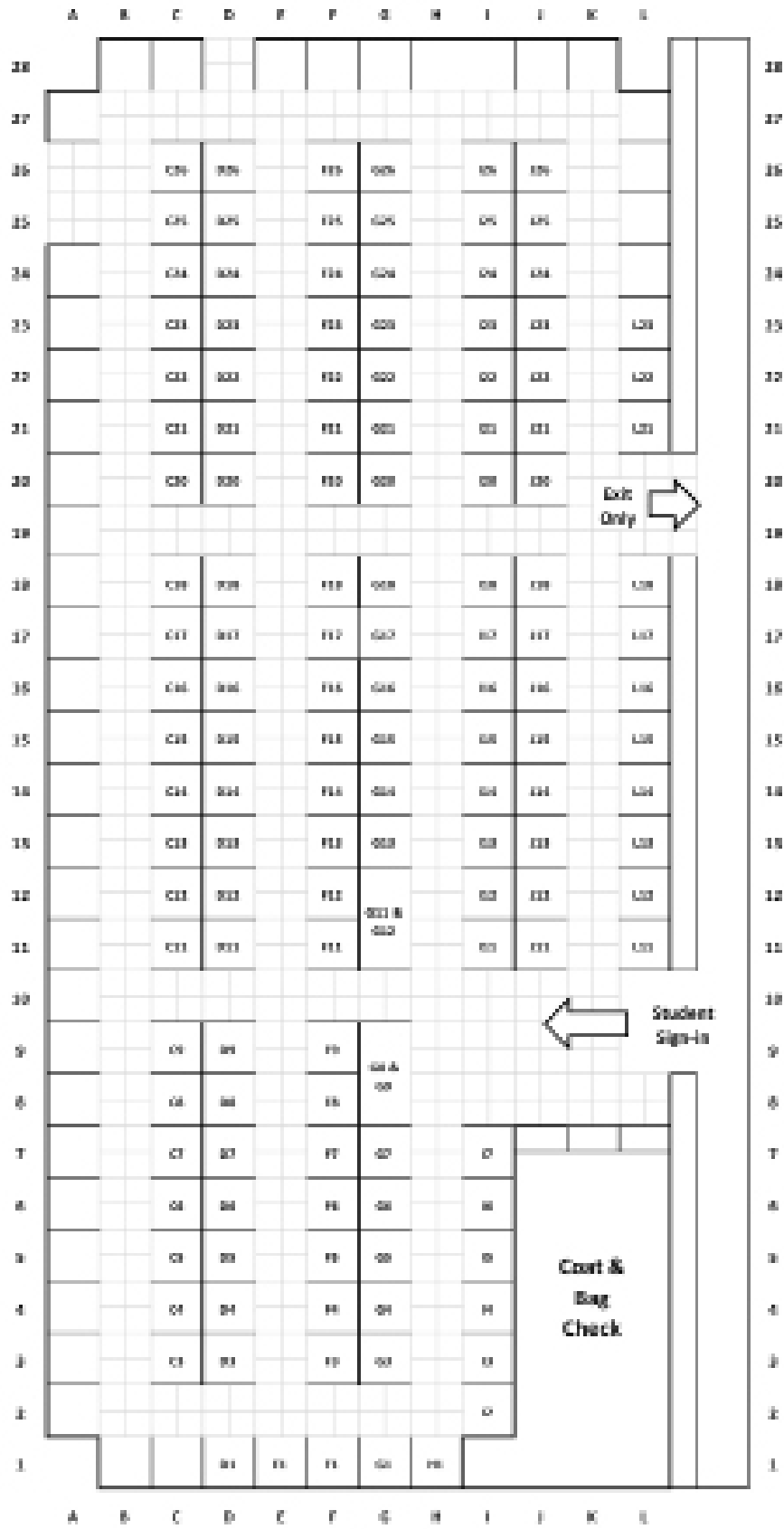

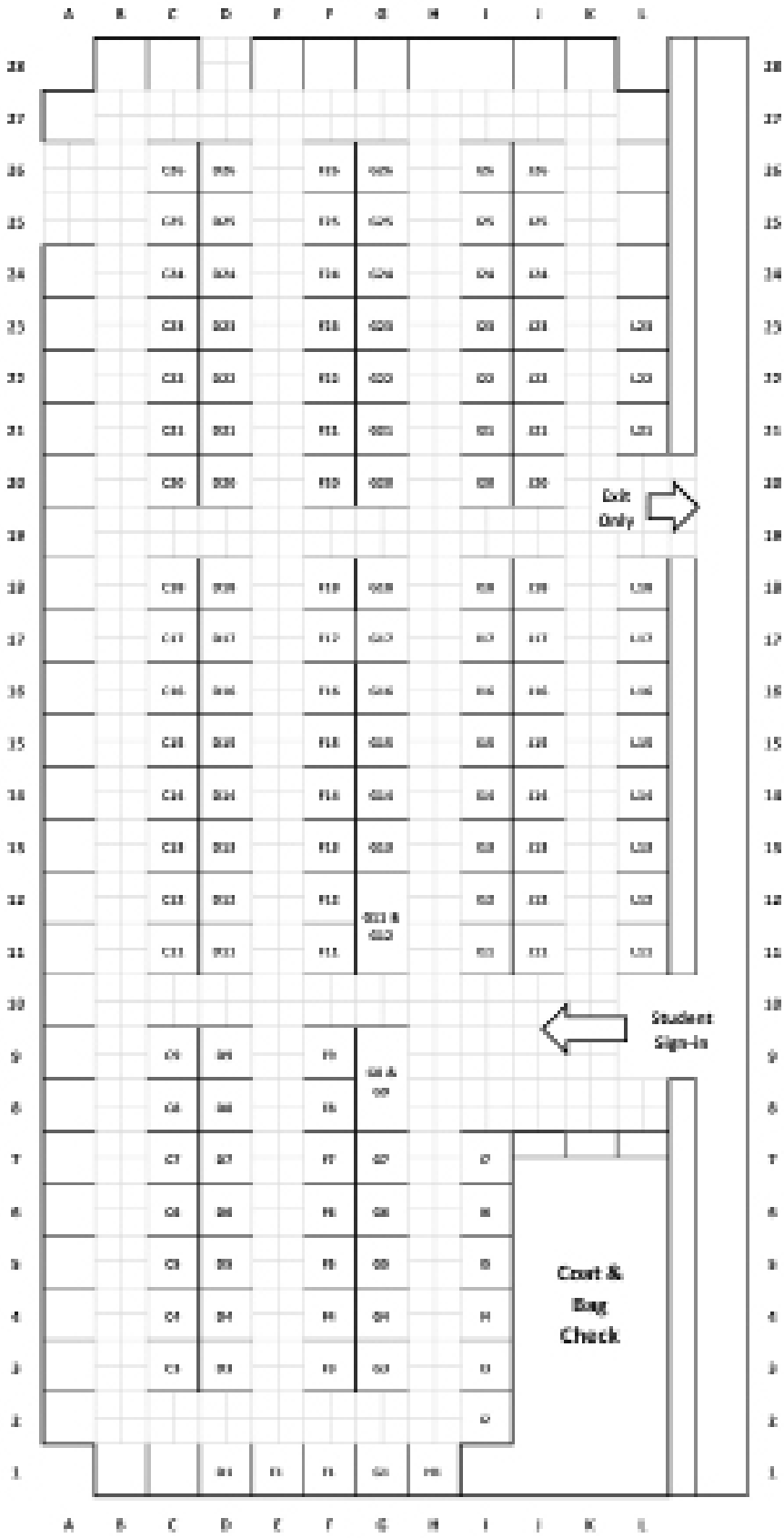

CAMPUS RECREATION CENTER MAP

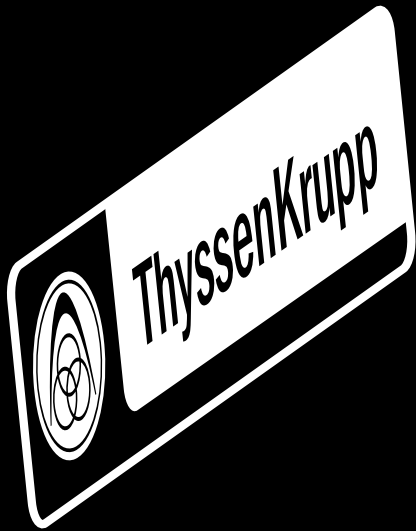
