- Active member of Provost's Dean's Council.
- Oversee all aspects of College of Nursing academic and research programs, faculty and staff
  workload and personnel issues (both groups unionized-AAUP, AFSME), undergraduate and

- In 2021-22, the pandemic and associated issues brought a decline in enrollment in most nursing schools in the State, including ours. Implemented new initiatives to respond including innovative Bacc2DNP program aimed at high school students, part-time options for various programs, increased all online programs, specialty certificates.
- Using a strong shared governance model, successfully completed major curriculum enhancements, created first Competency-Based Education RN to BSN program in the State, major updates and revisions of Graduate Entry Master's Program, and Doctoral of Nursing Practice Program; overseeing implementation of AACN Essentials across all levels.
- Orchestrated major needed "climate change" in the College when I first arrived with many team building strategies, developed with faculty and staff professional behavior expectations, enforced these, and now continue to promote a positive culture of civility, support, and excellence.
- Revised and increased standards in our promotion and tenure guidelines (via a participative process with our faculty and AAUP union that included 11 faculty forums); promoted faculty and student scholarship; increased publications, presentations.
