





CSR Robbery Reports: Year-to-Date 2022











CSR Auto Theft Reports: Year-to-Date 2022









CSR Burglary Reports: Year-to-Date 2022






CSR Burglary/Breaking & Entering Offenses

Personnel Updates

- Sergeant process final interviews scheduled for June 15th
- Currently conducting hiring processes for Emergency Communications Dispatchers, Police officers and Security officers.

Use of Force

- March 7: A Police Officer discharged a CEW at a fleeing suspect.
 - Consistent with training and Use of Force Policy
- April 5: Two Police Officers used leverage displacement and joint manipulation to place a subject into handcuffs.
 - Consistent with training and Use of Force Policy
- May 3: A Police Sergeant responded to an officer needs assistance call and used leverage displacement to assist CPD Officers in placing a subject into handcuffs.

Display of Force

- April 4: A Police Officer displayed a CEW and used laser light compliance to place a suspect in custody.
 - Consistent with training and Use of Force Policy
