President Williams about to be, welcome. We welcome you to the university on what is an historic day and an historic week. You must say that we got off to a great start by beating Rutgers 47 to 15. (Applause) It's not many schools that can beat a conference rival to open the season on national television and turn around two days later and appoint a new president with such character, integrity, commitment, and experience that will provide absolutely phenomenal leadership for this university. To the Search Committee, congratulations—you did a wonderful job. I don't think anybody believed it could have been done in this time period. But more so, it was an incredibly thorough, positive effort that has born just wonderful results for our university.

Thank you, Mr. Chairman. Firstly, I want to echo something that Tom Humes said. I want to compliment the Chairman and the Search Committee on an amazing professional job that brought us the ability to look at tremendous talent for this incredible appointment.

The definition of success, I believe, is that when you succeed in an area and are respected nationally, as Dr. Williams is, the one place you want to do to prove total respect is to come back to the roots that you started at. And, he's home back in the Midwest. With an amazing career starting at Muncie Central High School; going to Ball State and achieving an incredible education including a PhD in Political Science; moving into the Ohio State Law School as its dean, and where has brought Ohio State an incredible pathway to success—it is not quite our law school, Dr. Williams, but it's a pretty good law school; an ability to raise money, one gift, \$30 million was paid on the

same day it was due (we are going to duplicate that here Dr. Williams); moved on to City College of New York and his leadership and his feeling of diversity and what he brought to that community increasing their enrollment by 50%, raising \$275 million, and getting under his auspices a new science building.

As a result of this autobiography he has been featured throughout the country and has set a moment of importance here in America and to have him here at the University of Cincinnati as our president, we are indeed fortunate. Dr. William, congratulations to you and congratulations to this entire board on your selection.
