#### **B.** Finance and Administration Committee

1. The Board of Trustees adopted a resolution accepting two recently announced Ohio Board of Regents Eminent Scholars Program Awards totaling \$1.37 million.

- 2. The Board of Trustees approved the Combined Insurance Company of America Retrospective Premium Calculation Agreement. The agreement allows the University to retain up to ten percent of the premiums collected, provided that the claims as of August 31, 2009 do not exceed the loss ratio provided in the Retrospective Premium Calculation Agreement.
- 3. The Board of Trustees approved naming the main conference/exhibit space in the Center for the History of Health Professions (CHHP) in honor of a gift of \$100,000 in memory of Stanley Lucas, M.D.
- 4. The Board of Trustees approved naming the Design, Architecture, Art, and Planning (DAAP) Library as The Karl J. Schlachter Memorial Library for Design, Architecture, Art, and Planning in honor of a \$1 million gift commitment from Mr. and Mrs. Mark Schlachter.
- 5. The Board of Trustees approved establishing and naming the Woliver Laboratory for Simulation and Education in Surgery in honor of a \$1 million gift commitment from Edward Woliver, M.D.
- 6. The Board of Trustees endorsed an \$800 million goal for the upcoming University of Cincinnati Capital Campaign. This goal was determined through a campaign feasibility study conducted by campaign consultants, Marts & Lundy that encompassed interviews with colleges, units and donors.
