Degree/Program: Associate of Applied Science (AAS) / Criminal Justice – Law Enforcement (CJ – Law Enforcement)

Target Institution: University of Cincinnati / College of Education, Criminal Justice, & Human Services

Degree/Program: Bachelor of Science (BS) / Criminal Justice (On-Campus or Online)

Introduction: This agreement details the <u>applicability</u> of courses from the Southern State Community College AAS CJ – Law Enforcement degree to the BS in Criminal Justice degree in the UC College of Education, Criminal Justice, and Human Services. Students who complete the AAS CJ – Law Enforcement degree at Southern State Community College have partially satisfied the UC General Education requirement.

Articulation Overview: Graduates from Southern State Community College who have followed the prescribed program and are accepted into the UC College of Education, Criminal Justice, and Human Services will enter with 65 hours of transfer credit applicable toward the Bachelor of Science in Criminal Justice degree.

Admission Criteria: Please note: completing the courses on the worksheet below does not guarantee admission to the UC Bachelor of Science in Criminal Justice degree program.

Minimum GPA: 2.0

BS Completion: Completion of this program may require more than four semesters to complete due to prerequisite requirements and the order in which required courses must be taken and are offered. UC academic advising staff will work with each transfer student to develop the most expedient pathway to graduation

Admission Period: Southern State Community College students must be admitted to the UC College of Education, Criminal Justice, and Human Services during the duration of this agreement (i.e. between August 2023 and July 2026).

Agreement Execution Date: August 2023

Agreement End Date: July 2026

EXECUTION, DURATION AND REVIEW OF AGREEMENT:

This agreement becomes effective upon its signing by the Deans of both Colleges and will remain effective for three years. At the end of this time, the agreement will be reviewed and may be renegotiated. Southern State Community College and the UC College of Education, Criminal Justice, and Human Services agree to keep one another informed as program changes affecting the agreement occur. The Deans of both Colleges will agree upon any future additions and/or amendments to this document in writing.

This agreement will be reviewed on an annual basis and is subject to change due to revisions in program curriculum.

As strong partners, Southern State Community College Criminal Justice program agrees to provide direct access to students in the last semester of their degree program to a University of Cincinnati representative. This could be in the form of a classroom visit or other opportunities to directly interact and educate students about the program at the University of Cincinnati. Southern State Community College Criminal Justice program also agrees to provide a graduation list with email addresses. The University of Cincinnati College of Education, Criminal Justice, and Human Services will provide success rates of incoming cohorts of Southern State Community College Criminal Justice students upon request.

Southern State Community College students are encouraged to work closely with their academic advisor to monitor possible changes.
