**Introduction:** This agreement details the <u>applicability</u> of courses from the Waukesha County Technical College AAS Health Information Technology to the UC BS Health Information Management (Online) in the UC Clermont College. Students who complete the AAS Health Information Management at Waukesha County Technical College have partially satisfied the UC General Education requirement.

**Articulation Overview:** Graduates from Waukesha County Technical College who have followed the prescribed program and are accepted into the UC Clermont College will enter with 56-59 hours of transfer credit applicable toward the UC BS Health Information Management (Online) degree.

Admission Criteria: \*Note: completing the courses on the appendices below does not guarantee admission to the UC BS Health Information Management (Online) program.

A successful candidate must:

- Complete online University of Cincinnati application
- Complete the Waukesha County Technical College AAS Health Information Technology
- Submit official transcripts of all colleges/universities attended

#### Minimum GPA: 2.0

**BS Completion**: Completion of this program may require more than four semesters to complete due to prerequisite requirements and the order in which required courses must be taken and are offered. UC academic advising staff will work with each transfer student to develop the most expedient pathway to graduation.

Admission Period: Waukesha County Technical College students must be admitted to the UC Clermont College during the duration of this agreement (i.e. between May 1, 2024 and July 31, 2027).

Agreement Execution Date: May 1, 2024 Agreement End Date: July 31, 2027

#### EXECUTION, DURATION AND REVIEW OF AGREEMENT:

This agreement becomes effective upon its signing by the Deans of both Colleges and <u>will remain effective for the duration outlined</u> <u>above</u>. At the end of this time, the agreement will be reviewed and may be renegotiated. Waukesha County Technical College and the UC Clermont College agree to keep one another informed as program changes affecting the agreement occur. The Deans of both Colleges will agree upon any future additions and/or amendments to this document in writing.

This agreement will be reviewed on an annual basis and is subject to change due to revisions in program curriculum.

# Waukesha County Technical College students are encouraged to work closely with their academic advisor to monitor possible changes.
