Introduction: This agreement details the applicability of courses from the Lorain County Community College AAS Business Administration-Management to the Bachelor of Technical & Applied Studies (Online) at University of Cincinnati Online. Students who complete the AAS Business Administration-Management at Lorain County Community College have satisfied the UC General Education requirement.

Articulation Overview: Graduates from Lorain County Community College who have followed the prescribed program and are accepted into the University of Cincinnati Online will enter with a maximum of 60 hours of transfer credit applicable toward the Bachelor of Technical & Applied Studies (Online) degree.

Admission Criteria: *Note: completing the courses on the appendices below does not guarantee admission to the UC Bachelor of Technical & Applied Studies (Online) program.

Minimum GPA: 2.00

BTAS Completion: The Bachelor of Technical & Applied Studies (Online) is designed to be completed in 5 continuous semesters as outlined in the attached Transfer Degree Map appendix. UC academic advising staff will work with each transfer student to develop the most expedient pathway to graduation.

Admission Period: Lorain County Community College students must be admitted to the University of Cincinnati Online during the duration of this agreement (i.e., between July 2021 and July 2024).

EXECUTION, DURATION AND REVIEW OF AGREEMENT:

This agreement becomes effective upon its signing by the Deans of both Colleges and will remain effective for three years. At the end of this time, the agreement will be reviewed and may be renegotiated. Lorain County Community College and the University of Cincinnati Online agree to keep one another informed as program changes affecting the agreement occur. The Deans of both Colleges will agree upon any future additions and/or amendments to this document in writing.

This agreement will be reviewed on an annual basis and is subject to change due to revisions in program curriculum.

Lorain County Community College students are encouraged to work closely with their academic advisor to monitor possible changes.
